2	The prohibitions under sections 2 and 3 shall termi-
3	nate with respect to an article on the date on which the
4	President determines and certifies to Congress that—
5	(1) the Government of the Russian Federation
6	has terminated its prohibition on the importation of
7	the article from the United States;
8	(2) the Government of the Russian Federation
9	and its proxies have withdrawn all military and
10	paramilitary forces from the internationally recog-
11	nized territory of the Government of Ukraine; and
12	(3) the President has received credible commit-
13	ments from the Government of the Russian Federa-
14	tion that that Government will not engage in hostile

action against Ukraine in the future.
