Dear Mr. President,

We write to express our strong support for the State of Florida's request for the activation of Public Assistance Category A (Debris Removal) as Hurricane Debby made landfall near Steinhatchee in Florida's Big Bend. We appreciate the approval of the Public Assistance Category B (Emergency Protective Measures) but believe that Category A (Debris Removal) is critical to ensuring the safety and recovery of our communities in the aftermath of the storm.

Hurricane Debby continues to bring severe weather conditions, including high winds, heavy rainfall, and flooding, posing a significant threat to public safety and infrastructure. By granting approval for Category A Public Assistance, we can efficiently mobilize resources, coordinate debris removal efforts, and mitigate the risks associated with post-storm debris.

The approval of Category A will enable local and state agencies to:
