Dear Chairs Rubio, Collins and Alexander:

As CEO of the Association of Women's Business Centers (AWBC), which supports the network of over 100 Women's Business Centers (WBCs) around the nation, I write in full support of the Coronavirus Aid, Relief and Economic Support (CARES) Act. During this time of great economic uncertainty, as small businesses collectively struggle at unprecedented rates due to the global COVID-19 pandemic, America's 12.9 million women entrepreneurs are looking to the government for support.

Your bill, the Keeping Workers Paid and Employed Act, included in the CARES Act, supports the nation's small business owners at a time of great need by expanding uses for the Small Business Administration's 7(a) loans and providing resources to WBCs to provide counseling, training, and other services for small business owners impacted by COVID-19. It further supports the health and economic security of women entrepreneurs by authorizing the SBA to grant resource partner associations, such as AWBC, the funds to establish an online platform for counselors to direct entrepreneurs to available Federal resources. Furthermore, we appreciate that you have solicited and accepted the feedback of thousands of WBCs who are also struggling during these troubling times and have waived the non-Federal match requirement for three months for all WBCs.

As the nation faces a growing crisis and mounting uncertainty, 30 million small businesses face the prospect of shuttering their doors indefinitely. The CARES Act helps illuminate a path forward for these businesses, and those they employ, by providing much needed financial support.
